News Alert: Paper FAFSAs Will No Longer Be Distributed to Schools

The U.S. Department of Education announced on September 13, 2007 that the 2008-2009 FAFSAs will **not** be available for schools to order via FSAPubs. Students will be able to obtain a paper FAFSA by calling the Federal Student Aid Information Center (FSAIC) toll-free at 1-800-4-FED-AID (1-800-433-3243). In addition, the Department will make available a PDF version of the

2008-2009 FAFSA that students can complete – either on the computer or by hand – and mail to the Department for processing.

Scholarship and Grant Updates

We are pleased to advise you of some new programs administered by SEAA that will benefit North Carolina residents seeking college funding, and some beneficial changes to existing programs:

EARN

The EARN program (Education Access Rewards North Carolina Scholars Fund), proposed by Governor Easley, will provide need-based grants to full-time, dependent students to obtain education at UNC campuses or community colleges during

the first two years of study. Eligibility is limited to students with family incomes not exceeding 200% of the federal poverty guideline. Students complete the Free Application for Federal Student Aid (FAFSA) to apply. The maximum grant amount is \$4,000, with the first awards to be made for the 2008 fall semester.

John B. McLendon Scholarship Fund

The John B. McLendon Scholarship Fund was established to provide two leadership scholarships, one for a male athlete and one for

a female athlete, at each of North Carolina's ten Historically Black Colleges and Universities, except that Bennett College for Women will receive funding for scholarships for two female athletes. The first \$1,250 annual awards will be made in 2008. Recipients will be selected by the campuses. Recipients must participate on a varsity team, demonstrate outstanding leadership qualities, be involved in the college or university community, and maintain high academic standards.

Changes to Existing Programs Administered by SEAA



Prospective Teacher Scholarship Loan (PTSL)

The following award amounts for this program are in place for the 2007-08 academic year:

\$2,500 per year if the student is a freshman or sophomore at a two-year or

four-year campus and \$4,000 per year if the student is a junior or senior at a four-year campus

North Carolina Legislative Tuition Grant (LTG)

The Legislative Tuition Grant Program, which provides grant awards to North

Carolina students attending private colleges and universities, has been expanded to include eligible students enrolled for at least 9 credit hours per semester. Eligible full time students will receive \$1,950 and part-time students will be eligible to receive \$1462 for the 2007-08 academic year.

Re-Open Process for the 2007-08 Prospective Teacher Scholarship Loan (PTSL) Program

This past summer, the NC General Assembly increased the funding for the Prospective Teacher Scholarship Loan program (PTSL) for the 2007-08 academic year. Effective immediately, the electronic application for PTSL has been re-opened and placed at www.CFNC.org/PTSL and will remain open until funds have been exhausted.

Current undergraduate students pursuing degrees that lead to teacher licensure are encouraged to apply for the PTSL program. **High school students should NOT apply at this time.**

High school students will be able to apply for the 2008-09 school year in January 2008.
