

## **CFNC.ORG TERMS OF USE**

### **COLLEGE FOUNDATION OF NORTH CAROLINA**

College Foundation of North Carolina (“CFNC”) is a free service provided by the State of North Carolina to help students and families plan, apply, and pay for college and explore careers. CFNC is an information dissemination initiative comprised of the collective efforts of its members: Pathways of North Carolina (the NC Department of Public Instruction, the NC Community College System, the NC Independent Colleges and Universities, and The University of North Carolina), the N.C. State Education Assistance Authority, and College Foundation, Inc. (the “CFNC Members” and each a “CFNC Member”). The CFNC Website is composed of various web pages operated by College Foundation, Inc., on behalf of the CFNC Members, and shall be defined herein to include CFNC.org and all other web pages operated or hosted exclusively by CFNC (the “CFNC Website”). The CFNC Website provides you access to the NCCareers.org website through a single sign on log in process, as more fully explained below.

### **AGREEMENT BETWEEN USER AND CFNC**

The CFNC Website is offered to you conditioned on your acceptance without modification of the terms, conditions and notices contained herein. Your use of the CFNC Website constitutes your agreement to all such terms, conditions and notices.

### **MODIFICATION OF THESE TERMS OF USE**

CFNC reserves the right to change the terms, conditions, and notices under which the CFNC Website is offered in our sole discretion at any time, including but not limited to the changes associated with the use of the CFNC Website. Your continued use of the CFNC Website following the posting of revised Terms of Use means that you accept and agree to the changes.

CFNC reserves the right to disclose aggregated data, or information or statements we publish without attribution to any identifiable individual, specific data, or statements that you separately and specifically agree we can share with the larger public or media, without infringing upon the user's confidentiality.

### **IP ADDRESSES**

When your web browser or email application requests a web page or email from another computer on the Internet, it automatically gives that computer the address where it should send the information. This is called your computer's IP address. The CFNC Website may collect IP addresses for purposes including, but not limited to, system administration, marketing CFNC services, and auditing the use of this site. Although the CFNC Website may log your IP address, it will not generally link your IP address to anything that would enable a third party to identify you. However, the CFNC Website may use IP addresses to identify a user when it is necessary to enforce compliance with CFNC Website Terms of Use or other terms of service or to protect our service, site, users, or others.

### **SINGLE SIGN ON**

When you create an account on the CFNC Website, you will have access to all of the resources offered under the CFNC suite of services, including the NC Residency Determination Service, the NC Assist Loan Program, the NC 529 Plan, and certain resources and functionality hosted on NCCareers.org. Your login credentials and the information you provide in your CFNC account profile are maintained in CFNC systems which authenticates your access to all of the aforementioned resources. The single sign on feature eliminates the need for you to maintain separate log in credentials for each resource. Please note that the NCCareers.org website is not operated by or under the control of CFNC.

### **COOKIES and PIXEL TAGS**

Some pages on this site may use “cookies”—small files that the site places on your hard drive for identification purposes. A cookie file can contain information such as a user ID to track the pages visited, but the only personal information a cookie can contain is information you supply yourself. These files are used for site registration and customization the next time you visit us. Some parts of the site may also use cookies to track user traffic patterns, in order to determine the

usefulness of the CFNC Website information to our users and to see how effective our navigational structure is in helping users reach that information. Please note that cookies cannot read data off of your hard drive. Your Web browser may allow you to be notified when you are receiving a cookie, giving you the choice to accept it or not. If you prefer not to receive cookies while browsing the CFNC Website, you can set your browser to warn you before accepting cookies and refuse the cookie when your browser alerts you to its presence. You can also refuse all cookies by turning them off in your browser. By not accepting cookies, some pages may not fully function and you may not be able to access certain information on this site.

The CFNC Website or individual CFNC Members may also use "pixel tags," also sometimes called web beacons or clear GIFs, in connection with some website pages and HTML-formatted email messages to, among other things, compile aggregate statistics about site usage, response rates and the effectiveness of outreach. A pixel tag is an electronic image, often a single pixel, which is ordinarily not visible to site visitors and may be associated with cookies on your hard drive. When you access these pages, pixel tags generate a generic notice of that visit. They usually work in conjunction with cookies, registering when a particular computer visits a particular page. If you turn off cookies, the pixel tag will simply detect an anonymous website visit.

CFNC is providing these links to you only as a convenience, and the inclusion of any link does not imply endorsement by CFNC of the site or any association with its operators.

### **NO UNLAWFUL OR PROHIBITED USE**

As a condition of your use of the CFNC Website, you warrant to CFNC that you will not use the CFNC Website for any purpose that is unlawful or prohibited by these terms, conditions and notices. You may not use the CFNC Website in any manner, which could damage, disable, overburden, or impair the CFNC Website or interfere with any other party's use and enjoyment of the CFNC Website. ### **PASSWORDS AND ACCOUNT SECURITY**

You agree and understand that you are responsible for maintaining the confidentiality of passwords associated with any account you use to access the CFNC Website. Accordingly, you agree that you will be solely responsible to CFNC for all activities that occur under your account. If you become aware of any unauthorized use of your password or of your account, you agree to notify CFNC immediately at 866-866-CFNC (2362). You agree to not share access to the CFNC Website.

### **SECURITY MEASURES**

The CFNC Website encrypts the data you input when in route between your browser and the CFNC Website server, and when in route between the CFNC Website server and some other browser or server. This practice helps prevent unauthorized third parties from intercepting and gaining access to your private data during transmission over the Internet. The CFNC Website uses Secure Socket Layer (SSL) encryption.

Data residing on the CFNC Website server is password protected, and access is provided only to the account holder who created the password, anyone to whom that account holder entrusts the password, those employees who require such access to administer and maintain the CFNC Website or to provide requested customer support to users of the CFNC Website, and those employees of CFNC Members who require such access to create reports based on aggregated information that is rendered no longer personally identifying in the aggregation process. Certain account information may also be shared with other authorized individuals such as guidance counselors or career counselors, upon consent from the account holder.

If any court of law, having the jurisdiction to decide on this matter, rules that any provision of these Terms of Use is invalid, then that provision will be removed from the Terms of Use without affecting the rest of the Terms of Use, which will remain in full force and effect.
